OHIO HEALTH CARE ASSOCIATION REGULATORY COMMITTEE

September 4, 2025, 12:00 p.m. Zoom Meeting

MINUTES

Chair Rapp called the meeting to order. The grid at the end of these minutes shows attendance.

Chair Rapp reviewed the OHCA Antitrust Compliance, Conflict of Interest, and Confidentiality policies. She acknowledged that links to these policies can be found in the agenda.

Chair Rapp asked if there were any questions related to the minutes of the previous meeting. None were noted, and the minutes were passed by consent.

Chair Rapp provided a summary of a recent survey experience at a Caring Place community. Eight contracted CertiSurv surveyors conducted the survey. She indicated that there was very little communication between the survey team and the community. The surveyors were persistent and asked multiple repetitive questions. They also asked for 6 months of gradual dose reductions for the entire building. The 2567 was late, and most of the citations were related to documentation. Theresa, from Windsor House, shared that during a recent survey the survey team insisted on using their phone as a hot spot, with remote access to resident records. Ms. Cassidy explained that during a recent meeting with Jill Shonk of ODH she indicated that a survey may need to use a hot spot, but it would be fine for a community to disable remote access after the surveyor leaves the building for the night. Tammy Selvey shared that a survey in her organization was long, primarily because of the iQIES software update. There was also a significant Life Safety focus. Valerie Youell questioned calculations of the health inspections star ratings. Ms. Cassidy will research her question, and provide an answer during the next meeting. Gwynn Ryder shared that one of her organization's communities had a federal oversight survey. The complaint was unsubstantiated, and overall the federal surveyor was very pleasant.

Heidi McCoy provided an update on survey statistics. Due to the iQIES conversion, survey data has not been posted to the QCOR website this month.

Tammy Cassidy provided an overview of a meeting she recently had with Jill Shonk, of ODH. She shared the committee's concerns with contracted surveyors and consistency. She discussed Ms. Shonk's responses, which largely involved calling the field supervisor if the community feels the survey team is not following ODH policies.

Ms. Cassidy reviewed the most recent Immediate Jeopardy Bulletin, and reminded the committee that additional survey results will be shared after they are updated on QCOR.

Ms. Cassidy shared that the final MDS 3.0 RAI Manual has been released. She shared that some of the most concerning changes include a change in definition of falls, which was explained, and a change in the definition of falls with major injury, which was also explained. These areas have the potential to significantly impact the quality measures, and Ohio QIP. A free-for-members presentation regarding the changes will be conducted on September 17th. A second, more in-depth presentation will also be provided in several weeks.

Ms. Cassidy provided a review of the CMS Falls with Major Injury Technical Expert Panel results, which led to the changes in the MDS 3.0 manual. She also explained the need for Optional State Assessment Manual Deletions for any OSAs completed on or after 7/1/2025.

Ms. Cassidy shared that QIO, Livanta, has changed their name. As a result, communities should ensure contact information is updated on documents such as the NOMNC.

Debbie Jenkins provided an update on the PDPM transition.

Ms. Cassidy shared information on new PREP resources for pressure ulcers.

Erin Hart provided an update on NATCEP, and explained comments which were developed by OHCA, and will be shared with ODH.

Heidi McCoy provided information on the Governor's Quality Conference, which will be conducted on October 2nd, and is free for two members of each community.

Ms. Jenkins provided an update on the Minimum Staffing rule.

Ms. Cassidy explained that there will be a pause to updating of Nursing Home Compare. This is related to the iQIES transition. Updates are not expected until October 2025.

Ms. Cassidy provided a reminder related to Skilled Nursing Facility Validation Audits, and the need to begin monitoring the iQIES system to ensure any audit requests can be acted on as soon as possible.

Ms. Cassidy provided an update on the AHCA Quality Awards, as well as the OHCA Excellence Awards, and encouraged committee members to participate.

Gwynn Ryder provided an update to the Schizophrenia Audit her organization reported on last month.

Ms. Cassidy reminded the committee that the AHCA Quality Award portal is now open, and encouraged providers to participate.

Chair Rapp announced that the next meeting is scheduled for October 7, 2025
