FY 20/21 DODD Budget Provisions

- Invested a historic \$370 million into Ohio's DD system.
- Partnership with county boards to invest \$253 million to invest in DSP HPC rate.
- Invested \$53.3 million to raise on-site, on-call rate.
- Doubled investment in Early Intervention to support Ohio children and families.
- Invested approximately \$50 million in ICFs through growth in the reimbursement rate.
- Further investments in Multi-System Youth and Transportation.

COVID-19 Financial Relief

- DODD has worked with partners and administration to advocate for one-time funding during pandemic.
- DODD purchased PPE, Pulse Oximeters, etc.
- DODD Payment Adult Day/NMT \$18.8M
- Appendix K #1 HPC/Shared Living \$74M
- OBM Portal ICFs 32.8M
- December BWC Dividend Approximately \$87M
- Appendix K #2 HPC/Shared Living/NMT/ADS \$79M (awaiting CMS approval)

FY 22/23 DODD Budget Provisions

- Continues priorities and funding from previous budget.
- Maintains FY21 Medicaid reimbursement rates for home and community-based services (HCBS) and Intermediate Care Facility (ICF) services.
- Continues investment from the previous budget that doubled funding for Part C Early Intervention to support Ohio's children and families.
- Satisfies the Ball v DeWine settlement agreement by maintaining funding for 700 state-funded IO waivers as well as continuing to support affordable housing and integrated day and employment services.
- Provides \$1M in new funding to bolster the state's efforts in the use of innovative technology for more
 Ohioans with developmental disabilities to be more fully integrated into their community and live with
 greater independence.
- Increases investment in supports for multi-system youth and their families by \$10.5M over the biennium.
