

## OhioRISE Child and Adolescent Needs and Strengths (CANS)

### Training Frequently Asked Questions (FAQ)

The CANS is a support tool in the clinical decision-making process to determine eligibility into OhioRISE and level of care and service planning. The Ohio CANS assessment tool has been developed for broad application across multiple systems, including youth involved in child protection, developmental disability, department of youth services, and mental health and addiction. This ensures youth only need to go through one assessment across multiple providers. The tool gathers all dimensions of the youth and family story to determine needs and strengths and integrates multiple storytellers capturing the voice of the youth and family to produce a full consensus-based assessment. The CANS is updated routinely over the course of treatment to continue ongoing care planning.

### 3. Which trainings do I need to take?


**If I am not currently certified on any version of the CANS:** Take the TCOM (3.5 hours) and Ohio Children's Initiative CANS Comprehensive (3.5 hours) → These trainings need to be taken sequentially TCOM → CANS Comprehensive and within the same month. Please make sure to schedule your trainings accordingly to obtain certification.

**If I am currently certified on a version of the CANS:** Take the Booster training (2.5 hours)





## 7. I have completed the live (virtual) training. How do I get certified on the CANS?


1) *Enroll in "Ohio Comprehensive CANS 0-20" Course by following the below steps (refer to screenshot below):*

- Log on to: [TCOMtraining.com](https://tcomtraining.com)

- Click the green 'Enroll' button




2) You will then have access to the 'Ohio Comprehensive CANS 0-20 (refer to screenshot below):


- This is the course you need to certify in. To do this, go to the last step in the course titled 'Certification Exam' and take and pass an exam
- If you have completed the live (virtual) training(s), you do not need to complete all 80 steps, just the certification exam
