DODD Home Test Kit Distribution Project

DODD, in collaboration with our state partners, has secured COVID-19 home test kits for distribution to providers that are not able to secure tests through other existing means, such as local health departments, libraries, health centers, or through open market sources. The home test kit supply is limited and should only be dispersed to non-CLIA providers who are unable to secure them through other local resources.

We are pleased to announce that we have partnered with COGs and County Boards in each region of the state, to serve as DODD Regional Home Test Kit Distribution Sites for providers that:

- Do not have CLIA waiver to administer the BinaxNOW Tests. A CLIA Waiver is a certification from CMS that allows an entity to perform certain laboratory tests. <u>How to Obtain a CLIA</u> Waiver from CMS
- Are not able to obtain testing supplies from other sources, such as local health departments, libraries, health centers, or through open market sources. <u>Ohio Department of Health</u> <u>Distribution Sites for At-Home COVID Tests</u>

Each DODD Regional Home Test Kit Distribution Site will:

- 1. Serve as a point of contact to receive requests from local providers and arrange pick-up of home testing supplies.
- 2. Verify that providers have been unable to obtain home test kits from other resources such as local health departments, libraries, health centers, or through open market sources.
- 3. Use discretion to limit the number of test kits that a single provider receives, due to limited supply
- 4. Track distribution of test kits and provide data to DODD
- 5. Contact the DODD Provider Resources and Support team member for fulfillment of provider requests when a provider needs test kits and can use tests that require CLIA waiver. DODD Provider Resources and Support Team Map
