















# House Bill 96: State Budget ID/DD HCBS Amendment

This amendment is about **making sure Direct Support Professionals (DSPs) get regular raises** and making sure the agencies that employ them can afford the raises.

### The Problem

We need steady increases, not big jumps every few years.

- The current budget says it is "continuing" the rate increases from the last budget. These are not new increases. It means **DSP pay will stay the same**, not keep increasing.
- This is a problem because **we need to pay DSPs a decent wage** to attract and keep them in this important job.
- If wages don't keep going up, we might lose progress we've made, providers will have trouble finding DSPs, and **people with disabilities might not get the support they need**.

### The Solution: This Amendment

If provider costs go up, DODD would adjust rates based on the process they establish. The legislature isn't setting exact increases but is **requiring DODD to review costs and adjust** as needed.

- Starting in 2028, this amendment requires the Department of Developmental Disabilities (DODD) work with people with disabilities, families, providers, county boards and others to come up with a way to adjust rates each year based on costs. This means we won't need a huge, sudden increase later.
- Before 2028, this amendment asks for smaller increases to help boost pay:
  - o 3.4% increase starting January 1, 2026 (enough for about a \$0.65/hour raise)
  - o **2.3% increase** starting January 1, 2027 (enough for about a \$0.45/hour raise)

#### The Cost

This amendment will cost the state about \$23 million in 2026 and \$38.9 million in 2027.
