Self-Directed Transportation Questions...

- Will SD Transportation have CAP within the Level One or SELF?
- Will SD Transportation be AUDITED by DODD?
- What rules will we follow?
- Will Counties need to prove that there is not NMT available? Are both services equally available?
- Do we have to prove cost effectiveness?
- Team decision at county level is the desire.

Waiver Services Grid Summary: In general, OACB and counties think we leave the SELF alone - DO NOT ADD new services — other than SD Transportation - Adding services could complicate the SELF just as Assistive Tech has complicated it. However, ADDING Services to Level One gives more flexibility and we would be in agreement With the understanding/commitment to items below.

- 1. FIX PDGS Rule Eliminating/Decreasing Emphasis of Medical Necessity and Least Costly Alternative
- 2. DODD Audits need Shift in Paradigm Medical Model to Habilitative Model
- 3. Develop consistent State wide interpretation of the rule
- 4. Remove all outdated GUIDANCE about PDGS
- 5. Develop Simple/Easy to Read Guidance for PDGS
- 6. Intense, Collaborative EDUCATION to DODD, Counties and People Served
- 7. State-wide, consistent county implementation while allowing individual teams flexibility.

CAPS for Waivers...

SELF - stay the same

Level One – eliminate buckets with Caps of....

Adult (graduated from school) \$45,000/span School Age \$30,000/span

Emergency Funds...

OACB and Counties propose the following...

No Emergency funds in either Waiver.

- SELF has not shown need of Emergency Funds helps to be planful across span
- Level One should not need Emergency Funds as we Eliminate Buckets. It should operate more similar to the SELF. Ultimately County Boards and people have Waitlist Assessment and local dollars if health and safety issue.
