- In 2020, 8,401 DODD Providers have provided services to individuals. Of these providers, **1,382** have provided Adult Day Array Services ( Traditional Adult DAY/VOCHAB, Employment, Step, Restart, and/or Non-Medical Transportation)

# Provider Overview



## **So far in 2020:**

- 1,178 providers have submitted billing for ADS Array services in Quarter 1 (January-March)
- 850 providers have submitted billing for ADS Array services in Quarter 2 (April-June)
- 1,054 providers have submitted billing for ADS Array services in Quarter 3 (July-September)
- 990 providers have submitted billing for ADS Array services in Quarter 4 (October-November)

**Of the 1,178 providers who provided Adult Day Array services in Q1, 86 have not submitted billing for any services since.**

- 51 of the 86 were independent providers mainly doing NMT.
- 35 of the 86 were agency providers
  - 6 were agency providers delivering only NMT
  - Remaining number is 29
    - 1 ESC
    - 3 ICFs
- CLE Team will reach out to 25 providers.
- We would like to take a deeper dive into Q2 and Q3 like Q1. This will require more data review.

**204 providers did not provide Adult Day Array service in Q1 but have provided Adult Day Array services since.**

- At first glance, Independent providers (HPC/shared living) picking up NMT services.
- Independent providers: 136
- Agency Providers: 59
- Missing Values: 6 (still working to see how these 6 are missing)
- 8 agency providers look to be new adult day (non NMT) providers that opened during COVID.

# Individual Data

These are individuals that had an Adult Day and/or Employment Service in January, February and March and have not received **any** services April - October:

- NE Region: 1,861 individuals
- NW Region: 512 individuals
- SE Region: 336 individuals
- SW Region: 775 individuals
- WC Region: 749
