Grant Overview

- Funded by the Ohio Department of Developmental Disabilities
- April 2024 January 2025
- Goals
 - Improve quality of life of individuals with I/DD
 - Increase access to a broad range of strategies to support decision-making
 - Build skills to detect abuse, neglect, and exploitation
 - Select preferred autonomous means of supporting decision-making
- APSI received grant in partnership with Clearwater COG, DSACO, Philipps & Graham, and Provider Power Moves, with support from Supported Decision-Making Network of Ohio

Target Audiences



Individuals with I/DD, people under guardianship, people at risk of guardianship, and transition-aged youth/young adults



Families of individuals with I/DD, family guardians, SDM supporters, and parents of transition-aged youth/young adults



I/DD professionals, DSPs/providers, SSAs/county board staff, OOD/employment supporters, and family advocates



Legal professionals, probate judges/magistrates/court investigators, attorneys, professional guardians, and legislators



Transition professionals, teachers/transition coordinators/school staff and Children Services



Health professionals, doctors/hospitals/advanced practice nurses and mental health professionals

Measure the impact of self-determination on individuals with I/DD.

Measurement tool with 23 questions on SDM, making choices, getting support, and identifying mistreatment

Piloted

Completed the tool with 10 adults

Next Steps

- Adapting tool based on pilot feedback
- Following up with pilot participants to address identified areas of need, then reassessing in December/January
- Considering opportunities for additional participants
- Anlayzing results to make recommendations to DODD
