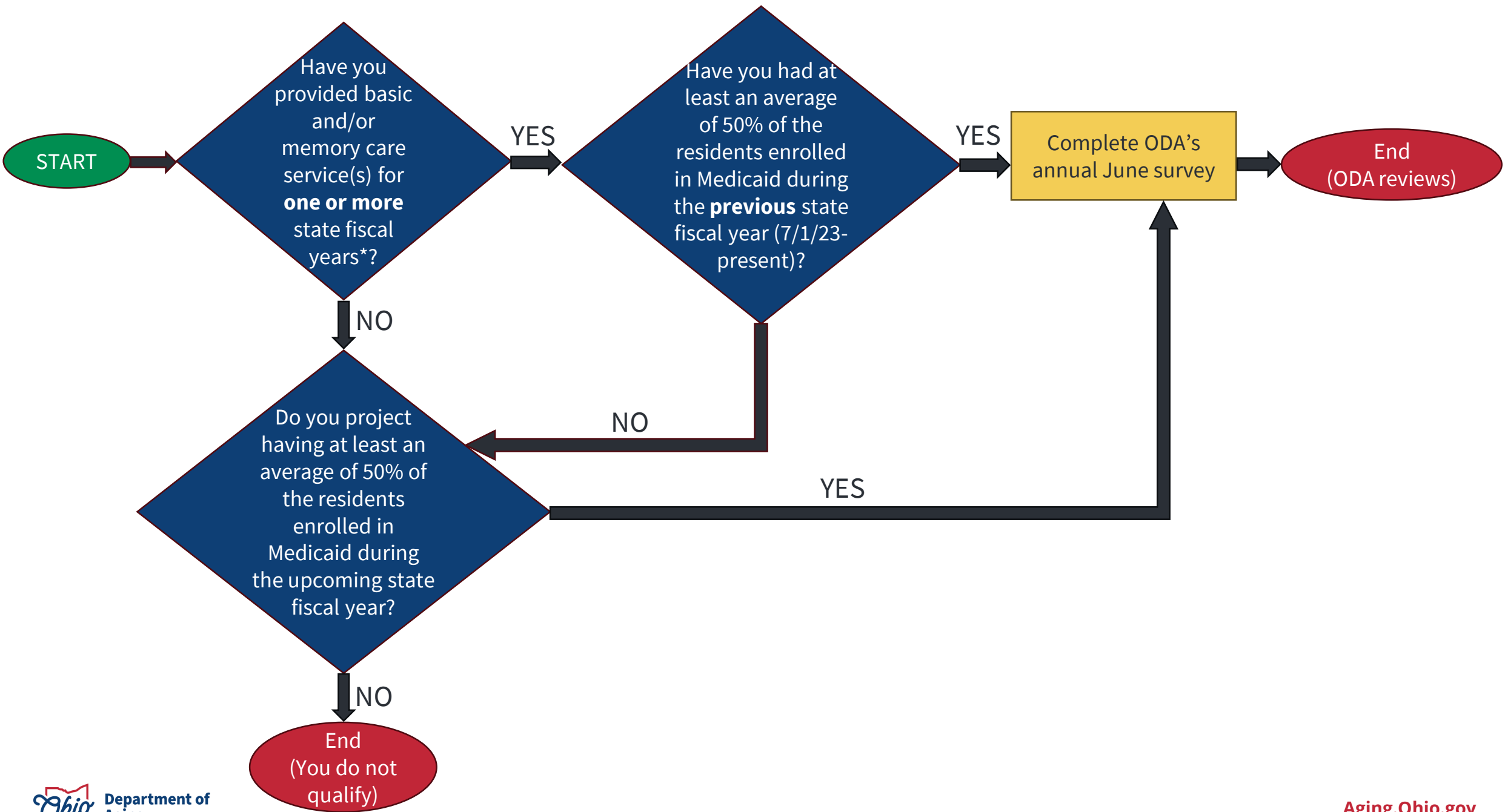

WHAT IS THE CRITICAL ACCESS RATE?

- ✓ At least an average of 50% of the residents are enrolled in Medicaid
- ✓ Critical access rate is **NOT** a service
- ✓ \$145/day (Assisted living-tier 2)
- ✓ Two ways to qualify:
 - ✓ Retrospectively
 - ✓ Prospectively
