Important BELTSS System Updates and Changes

New System Launch: BELTSS will soon implement a new online system, **Thentia**, which will handle renewals and applications. This link will not be active until **October 27, 2025**, but will be how to access the portal at that time: https://beltss.portalus.thentiacloud.net/maintenance/portal/#/

- Your login will be your personal email address on file with the Board as
 of October 7, 2025. Please log in to your current account before
 then and make sure your personal email is what you want it to be.
- You will use the "Reset Password" option on the licensee portal to get access to your existing account and set your new password once Thentia goes live.

System Downtime & Migration:

- The renewal part of the MyBELTSS system is currently shut down for all but **October 1, 2025**, renewals. If you are due to renew at another time, you will not be able to complete your renewal application and pay until the new system comes online on **October 27, 2025**.
- October 1, 2025, renewals may log on and pay electronically for their renewals between now and 5:00PM October 8, 2025. Renewals paid for after September 27, 2025, will be subject to the new renewal fee. Fee changes are going into production at 6:00 PM on September 27, 2025. October 1, 2025, renewals completed after September 30, 2025, will be subject to a late fee.
- The last date to upload CEs or make any changes in the current MyBELTSS is October 7, 2025. CEs that are uploaded on the 7th may not be processed until after the go live date and may have to be uploaded again.
- Renewals not completed by 5:00 PM October 7, 2025, cannot be accessed by the licensee or the BELTSS staff until October 27, 2025...please plan accordingly.
- The new system will soft launch on October 20, 2025, and go fully live on October 27, 2025.
- Data entry may resume on **October 27, 2025**.
