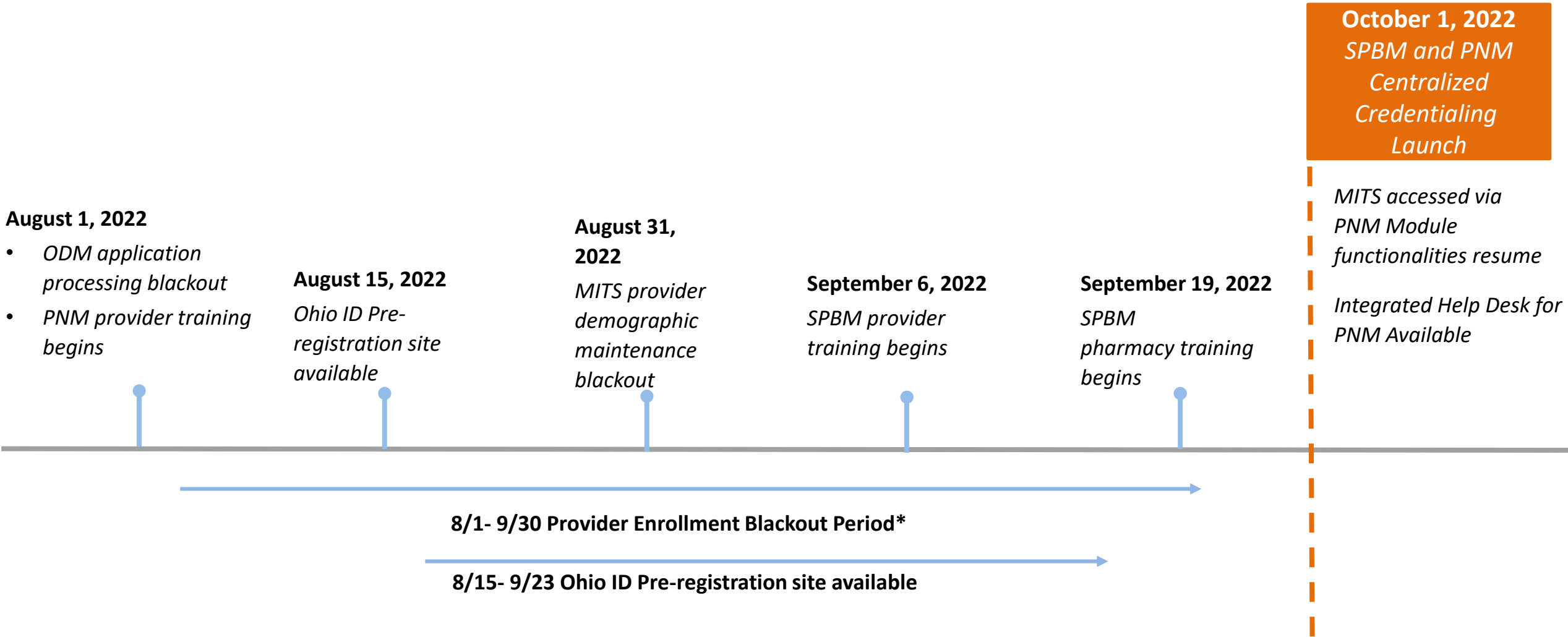

MITS Blackout and PNM Revalidations

- MITS is currently not accepting new enrollment applications
- CHOP Process – can continue sending in 45 day notices, must wait until 10/1 for the entering provider application
- Month of August – clearing out applications that are in process
- Backdating – provider enrollments can always be backdated up to 1 year provided that the license (if applicable) and NPI are effective as of that date
- Revalidations will resume with the PNM system go-live (October 1st) – 120 day notices for revalidations due 2/1/2023 will be sent 10/1/2022
