# Online Training Course Format:

Join the live program from your office, home, or hotel room using a computer with high speed internet. You may ask questions, participate in surveys, and post comments from your computer during the program. Please note that credit (if available) is only provided to registered attendees participating at their own computer and phone. Simple instructions with a link to the program will be sent when you register and again the day before the webinar.

The course begins with two days of state-specific training encompassing the current climate of home and community based services in Ohio. Training will cover such things as survey and regulatory management, working within the continuum of care, marketing, legal compliance, risk management, personnel requirements as well as clinical operations management.

Following the initial two days of training, you will be given self-study materials and will be required to complete the projects prior to the beginning day 3.

The final two days of training will cover NAB's areas of practice within the home & community based services arena.

**The Certified Executive for Home Care and Hospice is a comprehensive certification program designed to elevate skills and professionalism.**

## **Validates Your Knowledge and Tests for Your Specialty –**

Working toward a certification helps you demonstrate to others and to yourself that you are competent and skilled in your field. The Certified Executive for Home Care and Hospice program tests for advanced knowledge and provides you with thorough information you may not receive elsewhere.

## **Shows Credibility and Earns Respect –**

Consumers and prospective employers like to see evidence that you have the education and skills to perform your job well, and clients appreciate being cared for by qualified professionals. Becoming a Certified Executive for Home Care and Hospice demonstrates your commitment to home and community-based services (HCBS) and shows that you are passionate about gaining advanced knowledge to provide the best care to your clients.

## **Keeps You Up-To-Date in Your Field –**

Regulations are constantly changing, and consequently, so are the expectations of home care and hospice executives. By maintaining your credential through recertification, you will stay on top of the most current knowledge, expectations, and best practices in HCBS and attest that your expertise is up-to-date.

## **Voluntary Vs. Mandatory –**

Since the Certified Executive for Home Care and Hospice credential elevates the standard of knowledge and skills in the HCBS profession, the more Certified Executives we have, the longer we can expect the State Of Ohio not to mandate licensure of HCBS executive directors and administrators.

## **Professional Advancement Opportunities –**

While Ohio currently does not require a certification or license to be a HCBS executive, several states do require licensure. Therefore, the Certified Executive for Home Care and Hospice program curriculum is aligned with the preeminent national HCBS examination, allowing credentialed HCBS executives in Ohio to meet national competency standards. The HCBS exam is also a step towards Health Service Executive certification, which offers portability among different segments of the increasingly integrated long-term services and supports profession and evidences enhanced qualifications for a variety of positions.





## Receiving Certification & Renewal:

### Initial Certification:

To receive initial certification, you must attend all four days of the Certified Executive for Home Care and Hospice course, complete the required self-study courses, score at least 85% on the state component exam, and pass the NAB HCBS exam.

### Certification Renewal:

To ensure continued competency as a Certified Executive for Home Care and Hospice, you must renew your certification annually. Renewal requires completing 15 hours of continuing education on subjects relevant to HCBS operations, management, and philosophy.

### The CEHCH Faculty:

The Certified Executive for Home Care and Hospice program faculty consists of professionals, chosen for their expertise and knowledge to make the program stimulating and challenging. They are leaders in key aspects of home and community-based services.

## NAB Home and Community Based Services Examination

The Certified Executive in Home Care and Hospice program is a comprehensive certification designed to elevate the skills and professionalism of home health, palliative, and hospice care executives in Ohio by combining national competency standards with state-specific training.

The Certified Executive program is aligned with the NAB HCBS examination, thereby allowing individuals who complete Certified Executive training to meet national competency standards.

The NAB exam consists of 55 questions that encompass independent living, adult day, home health, palliative, and hospice care. The purpose of the examination is to protect the public by ensuring that HCBS executives have mastered a specific body of knowledge while demonstrating the skills and abilities essential to competent practice within the profession.

## What is NAB?

About the National Association of Long Term Care Administrator Boards (NAB): NAB is the nation's leading authority on licensing, credentialing, and regulating administrators of organizations along the continuum of long-term services and supports.

The mission of a NAB member state regulatory board or agency includes public protection of the residents and clients of America's skilled nursing facilities, assisted living communities, and home and community based services. As such, NAB strives to support member boards and agencies in carrying out their mission through the development and provision of entry-level competency examinations, standards, shared resources, and tools to assist them in their role of licensure of nursing home, assisted living, and home and community based services administrators. NAB examinations are also used as a component in meeting the eligibility criteria for professional certification programs.

Certified Executives for Assisted Living® (CEAL®): 26 hours of continuing education credit can be used toward CEAL® renewal.

Ohio Licensed Nursing Home Administrators: OHCA is an approved provider of continuing education credit by the Ohio Board of Executives for Long Term Care Services and Supports (BELTSS).

Administrators can earn 26 hours of continuing education credit.

## Course Prerequisite:

**To register for the Certified Executive for Home Care and Hospice course, you must meet one of the following criteria:**

- Hold a bachelor's or master's degree with at least 3 years of home health/hospice administrator experience;
- Hold an associate degree with at least 4 years of home health/hospice administrator experience;
- Have a high school diploma with at least 5 years of home health/hospice administrator experience;
- Be a licensed nursing home administrator or a Certified Executive for Assisted Living® (CEAL®);\*
- Be a licensed professional in a health-related field.\*

*\*Please note: it is recommended to have at least one year or more of hospice/home care administrative or upper-level management experience prior to attending this course. If you have no experience in hospice or home health, the Fundamentals of Home Care and Fundamentals of Hospice courses are recommended as a pre-requisite. Please contact OHCA staff for information on our bundle deals for these programs.*

*The Ohio CEHCH Training Course is a combination of interactive classroom training, self-study and hands-on learning.*

## Program Fee Rates: \$695

Students will register and pay for the NAB testing separate and apart from CEHCH program fees.

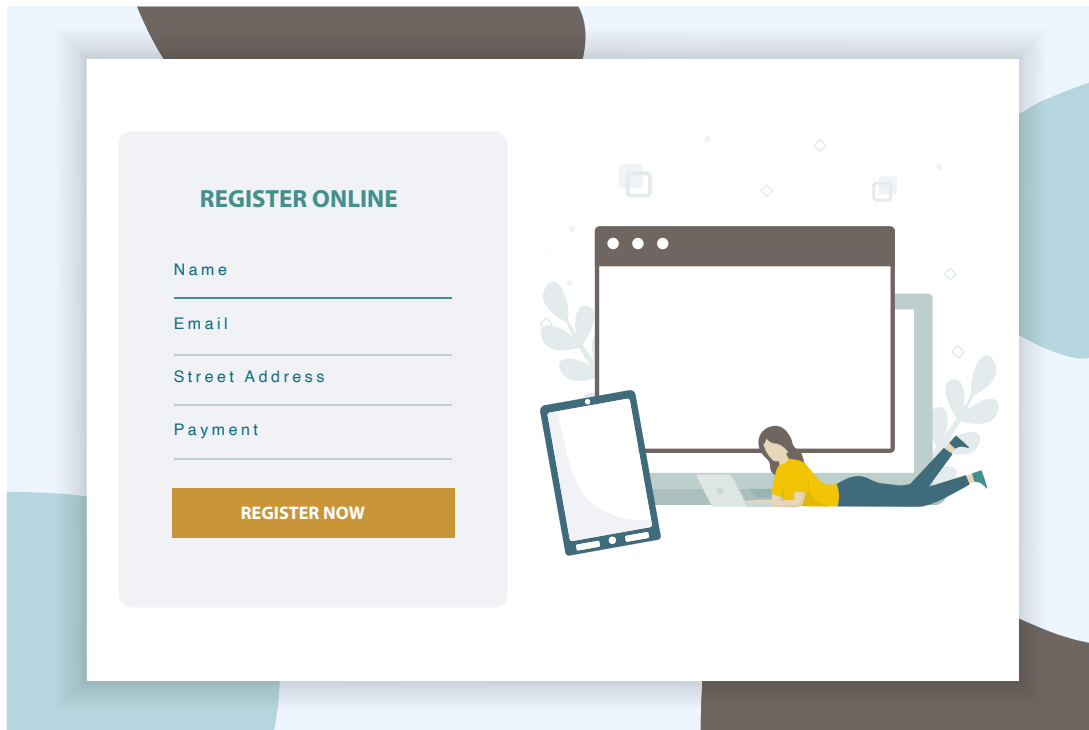

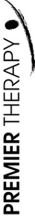
