SCHOLARSHIP PROGRAM

Scholarship Award of \$2,000, \$4,000, \$8,000 or \$12,000

The Educational Foundation of OHCA (EFOHCA), established in 1989, has the primary mission of fostering post-acute and long-term care careers. Since we began, we have helped adults, like you, go to school to advance their professional careers while contributing to a better healthcare workforce. Since our establishment in 1989, we are proud that EFOHCA has awarded over \$2.1M in scholarships to more than 1000 individuals. EFOHCA also awards scholarships for certification programs in the amount equal to 50% of the certification course cost, not to exceed \$1,500.

Scholarship Criteria

- You must be an employee or be related to an employee who has worked for a minimum of 1 year as an Ohio Health Care Association member.
- You must be enrolled or are about to be enrolled in an institution of higher learning which offers accredited courses for obtaining a certificate, baccalaureate, or post-graduate degree required for a career in long-term and post-acute health care.
- You must be a student enrolled for the school year or certification program running July 1st through June 30th of the next calendar year.
- You may only use scholarship dollars for unmet educational expenses billed through your institution (i.e., tuition, fees, books, supplies, and room and board). They will be payable directly to your school.
- You must return any unspent funds to EFOHCA after your degree or disenrollment from your learning institution.
