GRADUAL DOSE REDUCTION

Our Gradual Dose Reduction Program involves evaluation of the use of psychotropic drugs in an effort to ensure their proper utilization with residents of a nursing care facility. In other words, a) the use of psychotropic drugs is based upon an appropriate differential diagnosis of current behavioral symptoms. b) potential causes of the behavioral symptoms from environment, psychosocial, and medical factors have been considered and ruled-out or otherwise identified and addressed through appropriate forms of intervention, and c) each resident's psychotropic drug regimen is free from Unnecessary Drugs, including drugs prescribed in excessive dosages, for excessive durations, without adequate monitoring and indications for use, and/or in the presence of adverse consequences.

A Gradual Dosage Reduction Assessment will be completed upon admission or initiation of a psychotropic drug and minimally, every quarter thereafter. The psychiatric clinician will evaluate each referred resident receiving a psychotropic medication.

If behavioral and/or therapeutic services were initiated by BCS's psychologist or MSW, then a behavioral and/or therapeutic treatment plan will be generated and a "mini in-service" will be available to unit staff that focuses on effective implementation of the behavioral/therapeutic program. Thereafter, the psychologist or MSW will be available for further consultation and re-evaluation of the resident's behavior to ensure progress toward the identified treatment goals, to amend the current treatment plan as needed and otherwise attend related Behavioral Planning Meetings.

EMERGENCY HOSPITALIZATION ASSISTANCE

BCS' Emergency Hospitalization Program has been designed to assist the nursing home staff and medical teams in the management of acute psychiatric disturbances. Recent studies indicate that at least 50% of all nursing home residents will present with a diagnosis of Alzheimer's disease and, of those, many will exhibit agitation as their cognition continues to decline and may require an in-patient psychiatric placement as a result. BEHAVIORAL MANAGEMENT MEETING / IDT PARTICIPATION

BCS will participate in your facility's Behavioral Management Meetings and conduct Gradual Dose Reductions and AIMS testing on a regular schedule. This participation will assist in ensuring that sufficient documentation is provided to justify the use of the medication including diagnosis, failed alternative options, regular review and documentation of why it would be contraindicated to withdraw such medications, and any objective data available in the medical record to support the efficacy of the medication (i.e., behavioral tracking data, nurses notes, etc.). In addition, participation in regular meetings will help support interdisciplinary team interaction, identify residents that may benefit from alternate treatment strategies and encourage better communication to promote the highest quality of life for residents at your facility.

TELE-MENTAL HEALTH SERVICES

BCS is proud of our Telemental Health Services Program for a clinical continuum of care under the name "Tele-Behavioral Care Solutions."

BCS realizes that in many areas throughout the Midwest, nursing homes face great challenges in accessing consistent and timely psychiatric and psychological care for their resident population. The time involved in traveling to see residents, the shortage of appropriately trained professionals in the area, and the resultant inability to provide the breadth of coverage required for continuity of care has created a serious problem for nursing homes in designated Mental Health Professional Shortage Areas.

BCS is utilizing telehealth and videoconferencing technology to reach out to residents in nursing homes for supplemental care we may provide on-site. Recent studies have shown outcomes do not significantly differ between on-site services and those delivered through telehealth. Nonetheless, while few clinicians challenge the superiority of on-site services over telemedicine or remote treatment alternatives, BCS firmly believes that its combination of on-site and telemental health services provides the most efficacious and efficient mental health service offering for those otherwise underserved facilities and residents. To this end, BCS works with its contracted facilities in assessing all factors such as clinician availability, geographic proximity, applicable costs and whether considerations to fashion an acceptable on-site/remote schedule continuum.

STAFF TRAINING SERVICES

Behavioral Care Solutions ("BCS") provides a variety of training services to facility staff as requested by management. Routine in-service and remote training on current research and trends in geriatric mental health issues are provided to our contracted facilities. A wide range of topics are available and can include Regulatory Trends in Long-Term Care, Understanding the F-757/F-758 Guidelines, Understanding Dementia, Dealing with Difficult or Problematic Behaviors, Understanding Psychiatric Medications, Medications in Managing Difficult Behaviors, Managing Aggressive/Violent Resident Behaviors in a Non-Pharmacological Way, Non-Pharmacological Psychotherapeutic Approaches, Anxiety Disorders, Common Psychological Conditions of Aging, Conflict Resolution Strategies, Depression in the Elderly, Trauma Informed Care, Human Trafficking Tutorial, and Cognitive and Mood Assessment and Evidence-Based Outcome Measurements in the Elderly. GENERAL CLINICAL SERVICES

Psychiatric Services

Our team of psychiatrists, nurse practitioners, and physician assistants coordinate the overall management of residents within the facilities and are available for consultation and crisis intervention. Medication management is provided to assist with anxiety, depression, and cognitive disruption commonly experienced by geriatric resident and those with longstanding psychiatric disorders. The psychiatry staff work in conjunction with our team of psychologists to coordinate cognitive assessment and therapy services. Consistent with applicable government guidelines and focus, all of our psychiatric staff are trained in the understanding of OBRA standards as they pertain to the newly expanded F-757 and 758 guidelines. BCS offers our Psychoactive Medication Review Program to all contracted facilities. This program is designed to ensure the highest degree of compliance with existing guidelines and the completion of required objective measures, applicable scales and testing. In addition, a member of our team would be happy to participate in your regularly scheduled Behavioral Management Committee Meetings to offer guidance and better coordinate our services with your staff.

Psychosocial Services

Our psychosocial staff are comprised of Geropsychologists, Neuropsychologists, Clinical Psychologists and Master's Level Social Workers (LMSWs). They provide on site evaluation and diagnostic services for both emotional and neurocognitive based difficulties. The BCS psychosocial service conducts routine screening for depression and anxiety with residents upon admission as requested by facility staff. They also provide functional and diagnostic assessment of cognitive skills in residents with a history of neurological disease or trauma. These services allow for appropriate medical planning, therapeutic intervention, and objective assessment of medication effectiveness.

Family Centered Services

BCS understands the vital role families play in the care and treatment of their loved ones. Accordingly, BCS is committed to working with families in both an educational and support context. Psychotherapy Services
