Committee Chair John Goodman called the meeting to order.

Mr. Goodman reminded everyone about the OHCA Antitrust Compliance, Conflict of Interest, and Confidentiality Policies.

The minutes from the March 20, 2023 meeting were approved.

Heidi McCoy then discussed Senate President Huffman's request for ideas for workforce programs in Ohio that he could introduce during this coming budget season. He wants ideas that are legislative/regulatory in nature that do not need to have any appropriation of funds. Ms. McCoy requested that any such ideas be forwarded to either herself or Pete Van Runkle.

Ms. McCoy asked for feedback from the RETAIN software demonstration that was provided at the March 20th workforce committee meeting. This staff training/in-service software would be provided under a CMP grant. Ms. McCoy also asked for suggestions for the use of CDC Strike Force Funds for nursing facilities. No committee members provided any verbal feedback or suggestions on either subject but were encouraged to contact Ms. McCoy via call or email.

Mandy Smith then provided the committee with an update on the CMP process here in Ohio. Ms. Smith reported that the department has hired a new manager to review these grants. ODM has reported that they are months out from approving any grants and that CMS is making it difficult to approve.

Ms. Smith went on to give an update on the RCF rule review process. A second draft of the revised RCF licensure rule changes have been provided and OHCA is reviewing and will draft comments.

Ms. McCoy provided an update from the AHCA Workforce Committee of which she is a member. The VISION Centre is a 501 (c) that's mission is the development of at least 25 robust university and college programs that train our future leaders, create 1000 paid field experiences, develop strong university, provider, and association partnerships, and do this all by the year 2025. In the on-line folder, slides are located and includes a link to the Directory of Senior Living Leadership Programs

across the U.S. Current Ohio programs include Bowling Green, Kent State, Shawnee State, Xavier University, and Youngstown State. Committee members were encouraged to talk to any programs that are not currently on the list to reach out to AHCA.

No other comments or questions were given, and the meeting was adjourned.
